- The core objective of the programme is to ensure effective implementation of Public Procurement Policy, Ministry of MSME, Govt. of India, for micro and small enterprises. Public Procurement Policy (PPP) mandates that every Central Ministry or department or Central Public Sector undertakings shall set an annual goal of procurement from micro and small enterprises, with the objective of achieving an overall procurement of minimum of 20% of total annual purchases of products produced and services rendered by micro & small enterprises. From 1st April 2015, overall procurement goal of minimum of 20% is mandatory.
- The objective is to create a common platform for match making and furthering the businesses of Micro & Small enterprises as well as economical and effective outsourcing opportunities to Government organisations and public sector undertakings, BDS providers and financial institutions which will catalyze the better growth and development of MSE sector.
